If the phone call becomes disconnected, please contact the non-emergency number again, and the system will recognize the phone number from the previous call. For all non-emergency and business-related issues, the Normandy Police Department phone number is 314-385-3300. Please know there is not a Police Officer in the building 24 hours a day and 365 days out of the year. Normal business hours of City Hall and Police Administration Services are Monday through Friday between 8:00 AM and 4:00 PM.
