OLD BUSINESS

1. Modification of Section 400.200

The motion for the first reading made by Aldermen A. Robinson was seconded by Alderman F. Blackwell for bill #24-06. Craig did the first reading of the ordinance.

On the motion made by Aldermen A. Robinson, seconded by Alderman F. Blackwell for the second reading, Craig did the second reading of the ordinance.

2. Approval Code Enforcement with the City of Normandy

1. Approval of Business Chicago Fish and Chicken Grill/ Sign Variance

The motion for approval of Chicago Fish and Chicken Grill to open a business at 1604 S. Florissant Rd. within the City was made by Alderman A. Robinson and was seconded by Alderman D. Johnson. The motion for the approval of the Sign Variance at 1604 S. Florissant Rd the plans call for a 3 x 10 (30 SF) sign on a 1,430 SF building. The City Code (415.200 B.2) states an attached sign cannot be larger than 1% of the building's square feet. In this case, the maximum sign size would be 1,430 SF X 1% = 14.3 SF.
