An Ordinance establishing and authorizing the Execution of a Preliminary Funding Agreement with 201 Evans, LLC

4. Approval of the IWorQ Agreement.

5. An ordinance approving a cooperation agreement with the St. Louis County Board of Election Commissioners and The City of Valley, Missouri to transfer certain responsibilities relating to candidate filings for general Municipal Elections for The City of Cool Valley, Missouri, and enter into a cooperation agreement.

6. An ordinance approving an additional sales tax on sales of adult-use marijuana and calling an election for voter approval of such tax.

The motion for the first reading made by Aldermen A. Robinson was seconded by Alderwoman E. Jones Collins for Bill #23-17. Craig did the first reading of the ordinance.

On the motion for the second reading made by Alderman D. Johnson, seconded by Alderman A. Robinson for the second reading, Craig did the second reading of the ordinance.

Bill#23-17 became Ordinance#3-1122-23 by the following roll call vote of the alderpersons. The vote was polled as follows: A. Robinson -Yes, E. Jones Collins – Yes, F. Blackwell- yes, D. Johnson- Yes. Motion Carried.

7. An ordinance approving a use tax for general revenue purposes at the rate equal to the total local sales taxes in effect for the privilege of storing, using, or consuming within the City any article of tangible personal property pursuant to the authority granted by and subject to the provisions of Sections 144.600 through 144.761 RSMo; providing for the use tax to be repealed, reduced or raised in the same amount as any city sales tax is repealed, reduced or raised; AND CALLING AN ELECTION FOR VOTER APPROVAL OF SUCH TAX.

On the motion for the first reading made by Aldermen D. Johnson was seconded by Alderman A. Robinson for Bill #23-18. Craig did the first reading of the ordinance.

On the motion for the second reading made by Alderman F. Blackwell, seconded by Alderman A. Robinson for the second reading, Craig did the second reading of the ordinance.

Bill#23-18 became Ordinance#2-1122-23 by the following roll call vote of the alderpersons. The vote was polled as follows: A. Robinson -Yes, E. Jones Collins – Yes, F. Blackwell- yes, D. Johnson- Yes. Motion Carried.

8. Resolution of the Board of Alderperson approval of Missouri, declaring its official intent to pursue the joint establishment of a multi-jurisdictional transportation development district with other participating municipalities.
